

# NUROL TEKNOLOJİ SANAYİ VE MADENCİLİK TİCARET ANONİM ŞİRKETİ WEBSITE COOKIE POLICY

As Nurol Teknoloji Sanayi ve Madencilik Ticaret Anonim Şirketi (hereinafter referred to as "Nurol Teknoloji" or the "Company"), we use certain technologies such as cookies, pixels, GIFs ("cookies") to enhance your experience during your visits to our online media. The use of these technologies is carried out in accordance with the legislation that we are subject to, especially the Personal Data Protection Law No. 6698 ("PDP").

The purpose of this Policy text is to inform you about the processing of personal data obtained by the users/members/visitors of the Website ("Data Holder") during the use of cookies during the operation of the Nurol Teknoloji website ("Website") operated by us. In this Policy Text, we would like to explain to you what kind of cookies we use on our Site and how you can control them.

As Nurol Teknoloji, we can opt-out of using the cookies we use on our site, change their types or functions, or add new cookies to our site. Therefore, we reserve the right to change the provisions of this Policy text at any time. Any changes made to the current Policy text shall be effective upon publication on the site or in any public media. You can find the date of the last update at the beginning of this policy text.

## Our Purposes of Using Cookies

### In General

As Nurol Teknoloji, we use cookies on our website for different purposes and we process your personal data through such cookies. These purposes are as followed:

**-Improving the basic functions which are required for our Website and Mobile Application to run.** For example, sign-in members do not need to re-enter passwords when visiting different pages on the Site.

**-Analysing our Website and Mobile Application and improving the performance of Website and Mobile Application.** For instance, integration of different servers that our Website/Mobile Application work on, detecting the number of visitors of our Website/Mobile Application and accordingly adjusting performance arrangement or making it easier for visitors to find what they are looking for.

**-Carrying out customizing, targeting and advertising activities;** Such as showing related advertisements with visitor's interest via pages and products that visitors view.

In accordance with the purposes stated in this Cookie Policy, your personal data shall be processed without your consent, in the presence of at least one legal basis for data processing which are referred to in second paragraph of the Article 5 of Data Protection Law. Otherwise, in the event of non-existence of legal bases for data processing which are referred to in Law,

your data shall be processed only with your explicit consent. In any cases, we may transfer your personal data, which is under the scope of hereby Cookie Policy, to the third parties that Ebebek benefit from their services, our subsidiaries, business partners and group companies in accordance with the mentioned purposes and legislation. We would like to clarify that, parties which your data is transferred can retain your data on any server around the world.

### **The Cookies We Use on Our Website**

You will find the different types of cookies we use on our website below. We use both First-party cookies (placed by the Site you visit) and third-party cookies (placed by servers other than the Site you visit) on our website.

#### **Necessary Cookies**

The use of certain cookies is necessary for the correct operation of our site. For example, authentication cookies that are activated when you sign in the website enable you to continue your active session when switching from one page to another on our site.

#### **Functionality and Preference Cookies**

These cookies remind you of your preferences and choices on the Site and make the services offered on our site personal for you. For example, it allows us to remember your choice of language on our website or the font size you selected when reading the text.

#### **Social Media Cookies**

These cookies collect information about your social media usage. For example, cookies may be used to create personalized ads or to use information from your Facebook/Twitter accounts to conduct market research.

#### **Performance and analysis cookies**

With these cookies, we can analyze your use of our site and the performance of our website to improve the services we provide to you. For example, with these cookies, we can identify which pages our visitors view the most, whether our site is functioning correctly, and potential problems.

#### **Targeting or Advertising Cookies**

We use cookies to provide you with products and services on or off our site. We may also cooperate with some of our business partners to provide you with advertising and publicity within or outside our website. For example, cookies may be used to track whether you have clicked on an ad that you see on the website, or if you have benefited from the service that the ad is referring to after the ad has attracted your interest.

### **What are your rights as a Data Holder?**

In accordance with article 11 of the PPD Law, Data Holders have the following rights:

- Find out whether their personal data has been processed,
- Request information about their personal data if it has been processed,
- Find out the purpose of processing their personal data and whether it has been used in conformity with that purpose,
- Find out the domestic/foreign third parties to whom their personal data has been provided,
- Request correction of their personal data if it has been processed with omissions or inaccuracies, and request notification of the third parties to whom their personal data has been provided, about the transactions performed in this way,
- Request deletion or destruction of their personal data, and request notification of the third parties to whom their personal data has been provided, about the transactions performed in this way, if the reasons for processing no longer apply to their personal data, which in any event, has been processed in accordance with the provisions of the PPD Law and other applicable laws;
- Object to any outcome of an exclusively automated analysis of their processed data that has had a negative result for the Data Holder involved,
- Request to be indemnified in the event of any losses incurred due to any illegal processing of their personal data.

If you submit your requests regarding these rights using the methods set out in the Personal Data Holder Application Form at <https://www.teknoloji.com.tr> your application will be processed and concluded as soon as possible and within 30 (thirty) days at the latest. Although the company does not charge any fees for the requests in principle, the company still reserves the right to charge fees based on the tariffs set by the PPD Board.

The Data Holder warrants that the information cited in the Explanatory Note on Cookies is complete, accurate and updated and that the Data Holder shall immediately update them if there is any change to this information. The company assumes no responsibility if the Data Holder fails to provide updated information.

The Data Holder acknowledges that if he/she makes a request preventing the Website from using any of his/her personal data, then he/she will not be able to benefit from the functionality of the Website fully, and personally bear the full responsibility in this context.
